I hereby apply for membership of Skate Australia (SA). I acknowledge that SA may reject this application at its discretion. I acknowledge that if my application for membership is successful I will be entitled to all benefits, advantages and services of the recreational membership. For the purpose of this declaration, 'SA' means and includes Skate Australia, its members (including Clubs) and their respective directors, officers, members, servants or agents.

**RULES:**

The SA Constitution:

- (a) Constitutes a contract between me and SA. I will be bound by the SA Constitution, any regulations made under the Constitution and the SA Rules and Regulations (Bylaws) and my club Constitution (if appropriate).
- (b) Is made in the pursuit of a common object, namely the mutual and collective benefits, of SA, the members of SA (including me) and skating activities;
- (c) Is necessary and reasonable for promoting the objective of SA and particularly the advancement and protection of skate activities.

I understand that the cover is limited to the following:

Medical and Dental Costs

The cover reimburses 85% of non-Medicare medical treatment including ambulance, hospital accommodation / theatre fees, orthotics, splints, prosthesis, treatments given by a dentist, chiropractor, masseur, naturopath, osteopath or physiotherapist. The maximum benefit is \$3,000. All treatment must be certified by a registered medical practitioner and not subject to any Medicare rebate. All claims are subject to a \$50 excess if no private health cover. Any expenses must be incurred within 12 months of the insured person sustaining the injury.

**INSURANCE - SKATE AUSTRALIA MEMBERS ONLY:** The participant/s acknowledge that their membership fee includes basic personal accident insurance taken out on their behalf which provides benefits in the event of death as well as a range of benefits such as non-medicare expenses, home help and rehabilitation arising from accidents while participating in SA Sanctioned Events.

**PRIVACY STATEMENT:** The Event Organisor and Skate Australia Inc collect the personal information on this form to enable the efficient provision and marketing of the Event. The Event Organisor and Skate Australia will only use and disclose the personal information collected for the purposes of (or purposes reasonably incidental to) providing and marketing the Event. "Event" means participation in a "Skate Australia Development Program at 'a registered venue and "Skate Australia" means Skate Australia Pty.Ltd., PO Box 4233, Robina, Queensland, 4226, and includes all directors, officers, members, agents and sponsors of that organisation.

In consideration for, and as a condition of my registration into the Event, including participating in any or all pre or post Event activities and social activities I hereby

- 1 Warrant that I am medically fit (including physically and mentally) to compete in the event and that I have not been advised otherwise by a medical practitioner.
  - 2 Agree that I am participating in Event at my own risk and acknowledge that all Skate Australia activities including skateboarding and/or roller/inline skating are risky and inherently dangerous and may result in serious personal injury including permanent disability and/or death to me as a participant in the Event and that may or will involve the risk of severe economic or property loss and damage and I understand that such injury or loss may result not only from my actions but from the actions, omissions or negligence of others.
  - 3 Warrant that I will inspect the competition area and all fixtures, fittings, equipment, and other things supplied, provided or used in or related to the conduct of the Event and agree that I will not participate in the Event unless I am completely satisfied with the adequacy and conditions.
  - 4 Agree to abide by the rules and regulations of the Event and Skate Australia and I will abide by all written and verbal instructions as may from time to time be given by the Event Organisor and/or their appointed personnel. I agree that failure to comply with any rule may result in disqualification from the event. I agree that I will at all times participate in the event with fair play and sportsmanship.
  - 5 Agree that except where provided or required by law and such cannot be excluded, it is a term of my participation in the Event (if accepted) that Skate Australia and the Event Organiser are each absolved from all liability and claims however arising from injury or damage however caused (whether fatal or otherwise) arising out of my participation in the Event. I acknowledge that where I am a consumer of recreational services, as defined by any relevant law, certain terms and rights implied into a contract for the supply of goods or services may be excluded. I acknowledge that these implied terms and rights and any liability of Skate Australia and / or the Event Organiser flowing from them, are expressly excluded by this registration form.
  - 6 Release and forever discharge Skate Australia and the Event Organiser from all and any claim, right or cause of action however arising, whether or not presently ascertained, immediate, future or contingent, which I may otherwise have for or arising out of loss of my life or injury, damage or loss of any description whatsoever and howsoever caused which I may suffer or sustain in the course of or consequent upon my participation in the Event.
  - 7 Indemnify and keep indemnified Skate Australia and the Event Organiser against any claim, right or cause of action howsoever arising, whether or not presently ascertained, immediate, future or contingent which I may have for or arising out of loss of my life or injury, damage or loss of any description whatsoever and howsoever caused which I may suffer or sustain in the course of or consequent upon my participation in the Event.
  - 8 Agree that the exclusion of liability, release and indemnity contained in paragraphs 5, 6 and 7 above may be pleaded as a complete bar to any claim, notice, demand, action, proceeding, litigation or judgment which has or may be brought or made or recovered against Skate Australia or the Event Organiser.
  - 9 Agree that, without limitation to the waiver, release and discharge contained in paragraph 5 above and the indemnity contained in paragraph 6 above, the liability of the Event Organisor and Skate Australia will be limited to that part of the Event which is located at or held on its premises and the Event Organiser will not be liable in any circumstances or to any extent for any action arising in relation to that part of the Event which is located at or held on the premises of another Event Organiser; and
  - 10 Agree and acknowledge by my participation in the Event that performing aerial maneuvers and specifically, inverted aerial maneuvers or off axis rotations ("Inverts") is inherently dangerous and carries a high risk of serious personal injury, illness, permanent disability and/or death which may or will result in severe economic and/or property loss and damage and I fully recognize and accept those risks.
- I have read carefully and understand this declaration, warrant, waiver and release, and having done so, I sign voluntarily.

**MEDICAL RELEASE**

I consent to receiving any medical, such as first aid, treatment that Skate Australia or the Event Organiser considers reasonably necessary during or after the activities.

**EXCLUSION OF LIABILITY:**

Except to the extent that the Trade Practices Act 1974(Cth) or other legislation applies, and cannot by contract be excluded, I agree that as a term of my membership that I absolve Skate Australia from all liability however arising from injury or damage however caused (whether fatal or otherwise) arising out of my membership and/or participation in any Skate Australia authorized recognized activity in any way due to any negligent act, breach of duty, default and/or omission one on the part of Skate Australia

As an activities participant I hereby agree to wear suitable protective equipment, as requested, at all times whilst I am taking part in any roller skating activities.
